Design consultancy assigned

The Shire of Irwin is contracting celebrity horticulturalist and environmental scientist Josh Byrne's firm to prepare an engineering design development for Port Denison foreshore.

Best known for his segment on ABC TV's Gardening Australia, Dr Byrne is also a research academic with his own consultancy in Fremantle.

According to council documents, Dr Byrne's senior landscape architect worked on the 2013 and 2016 revised masterplan for the foreshore,

which was the concept stage of the project.

At its April meeting the council voted to source design development for the project from Josh Byrne and Associates and proceed with a survey of the Port Denison foreshore by Geraldton surveyors HTD

Cr Isabelle Scott made the motion. which also included transferring \$100,101.10 from the Port Denison foreshore development reserve fund for the design development and survey work. Cr Sandy Gumley seconded the motion and all councillors agreed.

Shire forgives \$10,000 rates

Irwin Shire Council has voted to waive a debt of more than \$10,000 in rates, interest and fees owed on an Allanooka property with no access

According to a report by rating officer Sharon Bonny, the 800sqm lot is landlocked, making it inaccessible and difficult for the Shire to recover the outstanding debt by selling it.

She said the owners of lots 123, 809 and 1163 Allanooka Springs Road had sold their property in 2005.

"At that time, it was overlooked that the contract of sale only included Lots 809 and 1163, excluding Lot 123, she wrote.

"Lots 809 and 1163 were then sold again in 2009. At this stage rates were being raised on all three lots."

Ms Bonny said Landgate advised the Shire of the error on the initial contract of sale.

The Shire then divided the property into two assessment numbers on its rating system, with Lot 123's rates being raised to the original owners.

It then tried to recover the outstanding rates on Lot 123 but the owners could not be contacted.

"In August, 2014, one of the owners contacted the Shire, which initiated the communication for the recovery of the rates debt," Ms Bonny wrote.

"The situation was prolonged and further complicated by the death of the joint owner and claims against the land from family members.

Late last year it was confirmed that the surviving owner was the property's rightful owner.

"The surviving owner does not have the financial capacity to settle the rates debt, and believes they do not have rightful ownership of the property as there has been no access or use of the property since the original sale in 2005," Ms Bonny wrote.

She said the debt had been accruing on Lot 123 since July, 2010.

The likelihood of recovering the rates debt is negligible," she wrote.

"It is recommended that council waives this debt, allowing the surviving owner to move forward by gifting or selling the lot."
